

POLISH-AMERICAN FEDERAL CREDIT UNION CREDIT CARD AGREEMENT AND DISCLOSURES

In this Agreement, the words "you" and "your" mean each and all of those who agree to be bound by this Agreement; "Card" means a Visa® credit card and any duplicates, renewals or substitutions the Credit Union issues to you; "Account" means your Visa credit card line of credit account with the Credit Union, and "Credit Union" means the Credit Union whose name appears on this Agreement or anyone to whom the Credit Union transfers this Agreement

1. Using Your Account. If you are approved for an Account, the Credit Union will establish a line of crect you and notify you of your credit limit. You agree that your credit limit is the maximum amount (purchases, advances, finance charges, plus "other charges") that you will have outstanding on your Account at any time. payment you make to your Account will restore your credit limit by the amount of the payment, unless yo over your credit limit. If you are over your credit limit and you have consented to the Credit Union's over-the coverage, you must pay the amount you are over before payments will begin to restore your credit limit. You request an increase in your credit limit only by a method acceptable to the Credit Union. The Credit Union the credit limit on your active and your end to the credit Union. the right to reduce your credit limit, refuse to make an advance and/or terminate your Account at any time f eason not prohibited by law.

2. Using the Visa Card. You may use your Card to make purchases from merchants and others who accer cards. In addition, you may betain each advances from the Credit Union and from other financial institution accept Visa cards, and from some automated teller machines (ATMs), such as the Visa ATM Network, that a Visa cards. (Not all ATMs accept Visa cards.) To obtain cash advances from an ATM, you must use the per identification number (PIN) that is issued to you for use with your Card. You agree not to make or permit made any illegal transactions on your Account through the use of a Card, a check or in any other manne may deny authorization for any Internet gambling transactions. If you wish to pay for goods or services ov Internet, you may be required to provide card number security information before you will be permitted to com the transaction.

3. Responsibility. You agree to pay all charges (purchases and cash advances) to your Account that are m you or anyone whom you authorize to use your Account. You agree not to authorize anyone to use your Account without the prior written consent of the Credit Union. You also agree to pay all finance charges and other ch added to your Account, Section 16 also applies to your Account.

4. Default. You will be in default if you fail to make any minimum payment or other required payment by th that it is due. You will be in default if you break any promise you make under this Agreement. You will be in def you die, file for bankruptcy or become insolvent, that is, unable to pay your obligations when they become due will be in default if you make any false or misleading statements in any credit application or credit update. Yo also be in default if the Credit Union in good faith reasonably believes that the prospect of payment or perform of your obligations under this Agreement is impaired.

When you are in default, the Credit Union has the right to demand immediate payment of your full Account ba without giving you notice. If immediate payment is demanded, you agree to continue paying finance charges periodic rate charged before default, until what you owe has been paid, and any shares that were given as s for your Account may be applied towards what you owe.

5. Liability for Unauthorized Use-Lost/Stolen Card Notification. You may be liable for the unauthorized of your Card. You will not be liable for unauthorized use that occurs after you notify the Credit Union, orally writing, of the loss, theft or possible unauthorized use. 6. Security Interest. If you give the Credit Union a specific pledge of shares by signing a separate pled shares, your Account will be secured by your pledge of shares and the specified amount will not be availat withdrawal while this Account is open and/or has a balance. 7. Finance Charges. The finance charges shown on your monthly statement are figured by multiplying a m 7. Finance Charges. The finance charges shown on your monthly statement are lighted by multiplying a fin periodic rate (MPR) times the average daily balance of both credit purchases and cash advances. The fin charges and the corresponding annual percentage rate (APR) are computed using a variable monthly rate, v may, at the sole discretion of the Credit Union change up to twelve (12) times a year. If rate changes occur, will be made on the first billing cycle following the 16th day of each month. The APR and its corresponding which goes into effect (or continues in effect) is determined by taking the prime rate as listed in the "Money R column in the Wall Street Journal on the last business day preceding the 16th day of each month.

Variable Rate. The variable APR for your Visa card will be calculated by adding a margin to the Prime (Prime + Margin). The margin will depend on our review of your credit history.

The **variable** interest rate is based on your credit history as indicated by your credit score provided by **Eq** As of January 2017 your rate will be between **6.90%** and **13.15%**. After that, your APR may vary with the n based on the Prime Rate but will not exceed 17.9%.

The monthly periodic rate is determined by dividing the above APR by twelve (12). The finance charge for advances and cash purchases are determined as follows:

- a.) Cash Advances: Finance charge on cash advances begins to accrue on the date you obtain the cash ad or the first day of the billing cycle in which it is posted to your account, whichever is later. There is no period on cash advances. The finance charges for a billing cycle are computed by applying the monthly pe rate to the average daily balance during the billing cycle, which is determined by dividing the sum of the balances for cash advances during the billing cycle by the number of days in the cycle. Each daily bala determined by adding new cash advances received to the previous balance for cash advances and subtr any payments received or credits posted to your Account, excluding unpaid finance charges.
- b) Credit Purchases: To avoid incurring any additional finance charges on the balance of credit purchases refit on your monthly billing statement, you must pay the new balance in full within 25 days of your statement of date. The finance charges for a billing cycle are computed by applying the MPR to the average daily bal of credit purchases, which is determined by dividing the sum of the daily balances for credit purchases of the billing cycle by the number of days in the cycle. Each daily balance is determined by adding new u purchases posted to your account to the previous balance of credit purchases and subtracting any payn received and credits posted to your account, but excluding any unpaid finance charges.

International Transaction Fee: A fee up to 2% will be assessed on all transactions where the merchant of differs from the country of the card issuer.

8. Payments. Each month, you must pay at least the minimum payment shown on your statement by the 8. 10. Other Charges. 11. Penalty APR. Before we apply the penalty APR on any type of transaction or balance, we will provide yo any notice required by law in advance that informs you which future transactions and/or outstanding balance subject to the penalty APR and when the APRs will increase. If we do not increase your APRs to the penalty when any of the events triggering the penalty APR occur, we reserve our right to increase your APRs to the per rate if any of these events occur in the future.

If your APRs are increased on any type of transaction due to the triggering of the penalty APR, the penalt will be applicable indefinitely to future transactions of that type that occur more than 14 days after we provide notice about the APR increase.

If we do not receive any required minimum payment within 60 days of the date and time due, the penalty Al be applicable to all outstanding balances and future transactions or your Account.
